Chairperson. A secret ballot was held for the election of the Chairperson, Governing Body. 9 votes were cast in the favour of Mr. Pankaj Gaur and 9 votes were cast in favour of Dr. Rajiv Nayan. Hence, Chairperson could not be elected due to tie.

3. Many members raised a point regarding the validity of membership of Mr. Rajiv Nayan. They quoted clause B 3(d) of EC Resolution No.51 dated 03.11.2012.

"No single individual shall be member of more than two Governing Bodies simultaneously."

The clause disqualifies Mr. Rajiv Nayan as he is on the G.B. of 3 Colleges.

- 4. It was resolved to seek following clarification from University of Delhi:
  - a. Whether employee/ex-employee/ex-students of the College can be elected as Chairman or Treasurer of Governing Body of the College.
  - b. Whether any member of Governing Body of Delhi Govt. Sponsored College can be members in more than two Governing Body.
